**ORDER ON PETITION FOR ACCESS TO PUBLIC RECORDS PURSUANT TO  
CHAPTER 119, FLA. STAT.**

THIS CAUSE, having come before this Court on the 23<sup>rd</sup> day of July, 2012 on Petitioner's, SCOTT ELLIS ("Ellis"), Petition for Access to Public Records Pursuant to Chapter 119, Fla. Stat., and the Court, after hearing argument, having reviewed the Court file, and being otherwise duly advised in the premises, it is hereby,

ORDERED AND ADJUDGED:

1. Petitioner Ellis' request for the letter dated May 21, 2012 from Krasney & Dettmer, P.A. and examined *in camera* by this Court is hereby DENIED as it is exempt pursuant to Section 447.605(3), Fla. Stat.

2. Respondent, MITCH NEEDELMAN ("Clerk"), shall have until 12:00 noon on Friday, July 27, 2012 to produce copies of the public records requests with regard to RoseWare, LLC, BlueGEM, LLC, and BlueWare, LLC and any related companies as requested by requestors Pasley, Nye, Doty, and Geaney ("subject requests") to Petitioner Ellis.

3. Respondent Clerk shall have until 12:00 noon on Friday, July 27, 2012 to produce Respondent Clerk's responses to the subject requests if drafted as of the date hereof to Petitioner Ellis.

4. Respondent Clerk shall, without further Order of this Court and within a reasonable period of time, provide Petitioner Ellis with copies of Respondent Clerk's responses to the subject requests as they are made after the date hereof, provided Respondent Clerk does so as quickly as practicable and at a reasonable charge of production as levied by Respondent Clerk.

5. Respondent Clerk shall provide the 17-page document between Respondent Clerk and the firm of Allen, Norton, Blue by 12:00 noon on Friday, July 27, 2012 upon payment of the following charge of production:

a)	17 pages at \$0.15 per page	\$2.10
b.)	Cost for research, verification, and production	\$18.46
	Total Payment Due:	\$20.56

6. Respondent Clerk shall release all electronic transmissions between Respondent Clerk and his agents and RoseWare, LLC, BlueGEM, LLC, and BlueWare, LLC as requested by requestors Pasley and Nye by 12:00 noon on Friday, July 27, 2012.

7. Respondent Clerk shall, within 48 hours of any current and future invoices, electronic fund transfers, related to RoseWare, LLC, BlueGEM, LLC, BlueWare, LLC and any related companies, provide the same to Petitioner Ellis at Respondent Clerk's customary rate of copy fees as authorized by Florida Statute.

8. Respondent Clerk may, pursuant to Section 119.071(4), Fla. Stat., require payment of reasonable fees for research and costs of production prior to producing such records as requested by Petitioner Ellis.
