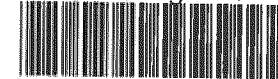



CONTINUATION OF STATEMENT:

Beginning July 29th, Randy Fine has employed a campaign of harassment on social media, with 37,000 followers, spreading lies and false allegations, inciting followers to harass and threaten me. He posted on Facebook "This is your opportunity to speak loud and strong" with my personal cellphone. I received hundreds of calls, texts, voicemails. From that point on Randy Fine posts lies on social media, daily, sometimes multiple times a day calling me "mentally ill", "child abuser", "prostitute". He is now spreading a website "brevardbores.com" all over his social media page, alleging an affair. It incites people to make graphic images of me in sexual positions, now circulating all over social media. He now makes statements "there is a special place in hell for her" on social media numerous times. This incites comments from citizens

"I'd find a better way to use that rope.", "rot in hell", etc.
Voicemails "you stupid bitch go to hell." I have
reason to believe he hired a Private Investigator
to follow me. Today @ 3:10pm, Fine posted a photo
of myself and daughter @ Publix, "enabled by Jenkins
a rope was used to tie a mask around her head for six weeks."
"Jenkins abused this child" "she's actively trying to cover it up."
Comments by citizens "she needs to be jailed.", "give them hell,"
"I have comments for her if I run into her @ Publix", "Karma is
going to hurt", "What a piece of shit", "that teacher needs
to be beat to death", "I hope you rot in hell" "what should
your punishment be?". A recent protest in September, protesters
stated "Read sent us, he says hello". They shout "we're going
to make you beg for mercy". I am terrified this narrative of
"child abuser" will incite violence, more threats, and harassment against
me or my family.

2. Petitioner asks the Court to enter, after a hearing has been held on this petition, a **FINAL JUDGMENT** for protection against stalking prohibiting Respondent from committing any acts of stalking against Petitioner and:

a. prohibiting Respondent from going to or within 500 feet of any place Petitioner lives, or to any specified place regularly frequented by Petitioner and any named family members or individuals closely associated with Petitioner;

b. prohibiting Respondent from going to or within 500 feet of Petitioner's place(s) of employment or the school that Petitioner attends; the address of Petitioner's place(s) of employment and/or school is:

c. prohibiting Respondent from contacting Petitioner by telephone, mail, by e-mail, in writing, through another person, or in any other manner;

d. ordering Respondent that he or she shall not have in his or her care, custody, possession or control of any firearms or ammunition;

e. prohibiting Respondent from knowingly and intentionally going to or within 100 feet of Petitioner's motor vehicle, whether or not that vehicle is occupied;

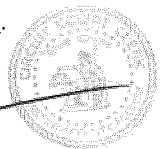
